[Title] Use of the UKCA Marking due to the Departure of the UK from the EU (Notice for Users in Japan)

[Date of Issue] July 2021

[Relevant Models] GOT2000 Series

Thank you for your continued support of Mitsubishi Electric Graphic Operation Terminal (GOT).

Due to the departure of the UK from the EU, products to be distributed/sold in the UK markets will bear the UK Conformity Assessed (UKCA) marking, instead of the current CE marking that certifies compliance with the EU's unified regulations.

Accordingly, we will affix the UKCA marking to our products sequentially from the October 2021 production.

This change does not affect the general specifications, performance specifications, functions, and external dimensions of the products.

1. Outline of the UKCA marking

The UKCA marking is a new marking that is required for specific products in the UK (England, Wales, and Scotland) markets.

The UKCA marking covers most products that require the CE marking.

Applicable products must comply with electrical safety (low voltage), EMC, RoHS, and other applicable regulations.

Without complying with the applicable regulations and having the UKCA marking, the products cannot be distributed/sold in the UK markets.

As of the issue date of this Technical Bulletin, the regulations and details required for the applicable products are the same as those required for the CE marking.

2. Products affected

GOT2000 series

(Except for products without the CE marking, discontinued products, and products to be discontinued)

3. Details of the change

The following UKCA marking will be affixed to the products and their packaging labels.

The UKCA marking, consisting of the letters "UK" stacked above the letters "CA" in a large, bold, sans-serif font.

4. Grace period for transition

Transition period	Distribution conditions in the UK markets
January 1, 2021 to December 31, 2021	Products with the CE marking instead of the UKCA marking can be distributed.
January 1, 2022 to December 31, 2022	Products with the CE marking can be distributed on condition that the UKCA marking is provided on the packaging and in the enclosed documents.
From January 1, 2023 onward	Products without the UKCA marking cannot be distributed.

5. Schedule

Compliance with the UKCA marking will be completed by December 31, 2021.

Considering the changeover period between products, we will distribute products with the UKCA marking in the markets sequentially from October 1, 2021.

Some products may be distributed in the markets ahead of the schedule.

There may be cases where products before the change and after the change exist in the distribution stage.
