# Response to Dechlorane Plus and UV-328: Prohibited Substances under the POPs Convention for Japanese Market

This bulletin informs you about our response to the substances newly added to Annex A (Elimination) of the Stockholm Convention on Persistent Organic Pollutants (POPs Convention).

This change does not affect the general specifications, performance specifications, functions, and external dimensions of the products.

## 1 Addition of substances prohibited under the POPs Convention

On February 26, 2024, the United Nations Secretary-General issued a notification to member states regarding the addition of three substances (Dechlorane Plus, UV-328, and Methoxychlor) to Annex A (Elimination) of the Stockholm Convention on Persistent Organic Pollutants (POPs Convention).

Signatory countries are required to establish the regulatory details and the start date for these regulations within their national laws within one year of the UN notification (by February 26, 2025).

If products containing the substances are regulated under the laws of each country, distributing or selling such products may become impossible after the regulations come into effect.

## 2 Response to the addition of prohibited substances under the POPs Convention for GOTs

For components of GOTs that contain Dechlorane Plus and UV-328, we plan to gradually switch to components that do not contain these substances. (However, this applies only to regulated countries and regions. In unregulated countries and regions, we will continue to ship products using the current components.)

There are no models that contain Methoxychlor.
